

## Iowa Judicial Retention Vote

The Iowa Judicial System is modeled on what is known as the Missouri Plan. One of the features of this plan is a retention vote. Because the justices in Iowa are not elected by the people, this ballot item introduces a system of direct accountability to the citizens. This fall, three justices will be up for a retention vote.

On April 3rd, 2009, the Iowa Supreme Court and all seven of its justices handed down a unanimous decision which struck Iowa's DOMA (Definition of Marriage Act). Their ruling took the effect of law when the plaintiffs in the case, several homosexual couples from Iowa, represented by their radical homosexual law firm, were then rewarded with "homosexual marriage."

The Iowa Faith & Freedom Coalition would like to encourage you to turn the ballot over this fall and vote on this retention issue. A yes vote is a vote to allow these three justice to keep their positions, while a no vote would remove them from the bench.
